EQUITY SUMMARY

Trinidad and Tobago

Trivial trading volumes continue to be the hallmark characteristic of activity on the local market, with less than half a million shares trickling across the floor this week. Only 466,569 shares were traded on the First Tier Market this week, a 58.77% reduction from the prior week's volume of 1,131,721 shares. The value of shares traded was also cut by over fifty percent, falling 54.71% from \$12,629,584.38 last week to \$5,720,251.96 this week.

Indices movement mirrored the week's price movements, with the week's major declines in cross listed securities taking a toll on the Composite and Cross Listed Indices. The Composite and Cross Listed Indices suffered weekly declines of 0.42% and 1.53% while the All T&T Index advanced contrastingly by 0.11%.

Jamaica

Positive indices movement persisted on the Jamaican market for yet another week, with the major indices once again posting advances. The JSE Market Index continued on its ascent moving by 44.56 points or 0.06%, the JSE Select Index added 5.72 points or 0.31% and the JSE All Jamaican Composite Index climbed 82.59 points or 0.12% to close the week.

FIXED INCOME SUMMARY

Trinidad and Tobago

- There were no OMO maturities for the week ended July 17 compared to \$100MM in the previous week.
- An interest payment for the NGCTT USD bond was paid on July 15.
- The auction of the TT\$682MM 6.80% fixed rate NIPDEC bond due 2022 closed on July 17, 2009.

US

- Treasury prices turned lower Friday, pushing yields toward the biggest weekly increase in a month and a half, after government data showed that the nation's housing construction improved more than anticipated last month.
- Ten-year note yields rose 6 basis points, or 0.06%, to 3.63%, which would be the highest on a closing basis since June 24. Week on week, ten-year note yields rose 30 basis points.
- Two-year note yields advanced 2 basis points to 1%. Short-term yields are on pace for the first weekly increase since early June, up from 0.90% last Friday.
- With the 10-year yield back above 3.6% the benchmark spread widened out to more than 260 basis points.
